The Summer Assembly at the Crowne Plaza Hotel in Fort Worth was a success. We registered 170 attendees, including 110 voting members and 60 others. We had 2 days of Assembly activities including 3 AA meetings. We were contracted for 98 room nights; with an 80% attrition clause, the number of required room nights was 79. Thanks to everyone who stayed at the hotel, we ended up with 90 room nights. Our coffee and food coupon income was greater than our expenses, and we paid only \$180 for meeting rooms. Our budget for Summer Assembly is \$700, yet we only spent \$252.

The Fall Assembly will be held at the Doubletree Hotel near the Galleria, located at 4099 Valley View Ln., Dallas, Tx 75244. This Assembly is also a Convention featuring renowned AA and AI-Anon speakers. It is a 3-day event, beginning Friday September 17 at 6 PM (Registration starts at 4 PM) and continuing through Sunday, September 19. We do charge a registration fee of \$10 for the Fall Assembly/Convention since we are inviting speakers and paying their expenses. Saturday June 18th, 2011 Business**

Area Chair Jana A called the assembly to order at 8:35 AM. The proceedings opened with a moment of silence followed by the Serenity Prayer and a reading of "Why Do We Need a Conference" by Jaime. Jana reviewed the assembly agenda.

Delegate Jim C attended the 2011 General Service Conference in New York, NY, beginning May 1st, 2011. He distributed his report of the 61st GSC Conference Advisory Actions, Additional Committee Considerations, along with synopsis of Conference discussion and debate. Followed by a Q&A session, moderated by Jim C.

Secretary Keith D made a statement that he made another mistake made for the mail-out – the 35 GSR's that are listed at wanting a mailed copy of the newsletter were mistakenly not included in the labels and instead the newsletter was mailed out to 150 GSR's that had indicated they wanted an email version only (the difference for printing was 115 copies.)

New Business

Motion presented by Newsletter Chair, Dusty W, on 4/10/11 at A.C.M.: Move to increase the NETA Panel 61 Printing Budget beginning with the second quarter of 2011 to \$600.00 per quarter.

Background: The budget for printing has been set at \$400.00 per quarter for several Panels. Printing costs, as well as the cost of paper, have gone up over time. During Panel 57 our printing was done by a shop that was owned by members of Alcoholics Anonymous. That print shop closed during Panel 59 and printing quotes were sought out and the printer used was Minute Man Printing in Greenville. That printer went up on their cost and the Newsletter printing for the last quarter of Panel 59 (the previous Panel to this one) had printing costs of \$535.00, which was \$135.00 over budget. The first quarter of Panel 61 (the current Panel) was over budget as well. We were able to get that printing done on a one time only basis (due to the print shop staff error that they would partially honor that one print job) for \$405.00 total. We have gotten over a dozen quotes from shops in Dallas, Greenville, Fort Worth, and the Mid-Cities. All the print shops were approached with the same information: printing to be done for a nonprofit organization, 16 tabloid pages with a single half-fold, 20 to 24 lb. weight paper, and the job to be shopped around and

awarded to the lowest bidder. We currently have a low bid of \$525.00 from one shop, based on that manager's goodwill. When the manager leaves that shop, the price will have to be renegotiated. The higher bids from other shops ranged from \$700.00 to \$1200.00 per printing. We are requesting a budget of \$600.00 with the intention of remaining under budget whenever possible by utilizing the current low bid of \$525.00, but with the understanding that print costs remain somewhat fluid and may be raised by the print shops at any time. A budget increase to \$600.00 should allow some adjustment to the cost of printing without having to come back so soon in the near future with a motion to request another budget change increase.

Outcome: Tabled to the end of business, and then withdrawn.

Motion presented by Alternate Treasurer, Pam C, on 4/10/11 at A.C.M.: The NETA Newsletter be condensed to a size that would cost no more than what is budgeted for Printing / Publishing.

Background: Do away with the letters from every area trusted servant and DCM in NETA. The area is looking for ways to reduce the cost of the Newsletter. Most of these articles are repetitive and unnecessary. A list of upcoming events, important information, and possibly an article from the Delegate and Area Chair could be included.

Outcome: Withdrawn.

Area Chair Jana A requested a sense of the assembly on different options for the meeting times of the Area Standing Committees. The consensus was evenly split between the option of having the committees meet before, after and during breaks and the option of not having the Saturday evening presentation, so that the committees can meet during that time slot.

Area Chair Jana A announced appointments for Area Inventory Review Ad-hoc Committee and Area Handbook Review Ad-hoc Committee.

GSR & DCM Sharing Sessions: Assembly broke into respective groups and discussed concerns and issues relating to their positions.

Secretary's Report – Keith D: The minutes of the Spring 2011 Assembly were read and accepted with amendments.

The summer mail-out is scheduled for August 6th at the Irving Group, 618 East Irving Blvd, Irving, TX. Subsequent mail-outs are scheduled for December 3, 2011, at Bruton- Terrace Group, February 4, 2012 (tentatively) at the ODAT Group in Texarkana; May 12, 2012 at Greenville Traditions Group and August 4, 2012 at McKinney Fellowship Group. Treasurer's Finance Report – Roy A: Distributed and reviewed the 1/1/11 – 6/18/11 Financial Statement. The beginning Operating Account balance was \$17,371.21 with contributions of \$16,487.50 and budget items paid of \$33,388.37. Panel 59 Trusted Servants returned funds in the amount of \$1,479.44. The ending operating account balance was \$1,479.44. The Prudent Reserve Account beginning balance was \$10,343.06 with interest of \$8.56 for an ending balance of \$10,351.62.

Alternate Treasurer's Report – Pam C: Referred to the policy that if you don't turn in receipts for two assemblies, you will not get a check.

Convention Chair Report – James V: Convention/Assembly Report from 1/1/11 – 6/14/11. Beginning account balance of \$0.00, income of \$8,100.95 expenses of \$7,053.50, and bank charges of \$15.00 with an ending account balance of \$1,032.45. There are prepaid deposits of \$700.00 for the Doubletree for the Fall Assembly. For the Spring Assembly, there were 73 coffee cards sold totaling \$73.00, coffee bar donations of \$5.00, 70 breakfast food coupons for \$770.00 and 62 lunch & dinner coupons for \$930.00, and meeting room credit of \$808.00. Spring Assembly expenses included \$32.47 for registration supplies, \$900.00 room expense, and \$1,700.00 for food coupons for total expenses of \$3,256.47. Income versus expenses was \$(13.47.) Attendance was 207, with 92 voting members registered.

Alternate Area Chair Report – Tom M: We've done 14 workshops this panel. Future workshops are listed in the Addendum section.

Alternate Delegate Report – Mo N: Provided a written report that included several upcoming events including the Summer Area Committee meeting at the Show Me Group in Denton, TX on 7/10/11 at 1:30PM.

Structure Committee Report – Past Delegate, Joe P: Structure committee electronic newsletter motion and consensus was that the motion might save the area money, but “At what cost?”

Delegate Jim C: Moderated a session of “What’s on your mind?”

The assembly concluded with the Lord’s Prayer at 11:15AM.

Area Chair Jana A called the meeting to order at 1:35 PM and opened with a moment of silence followed by the Serenity Prayer and a reading of “AA’s Legacy of Service by Bill W” by Linda Winter.

Secretary Keith D: read the minutes of the Spring 2011 Area Committee meeting. Corrections made to dates and location of Summer Assembly. Minutes were accepted with corrections.

Alternate Secretary Olga R: Upcoming Summer mail-out will be at Irving Group on 8/6/11.

Treasurer Roy A: Distributed and reported on the Financial Statement for 1/1/11 thru 7/8/11. The beginning Operating Account balance was \$17,371.21 with contributions of \$17,294.33 and budget items paid of \$34,963.37, Panel 59 funds returned of \$1,479.44 for an ending Operating Account balance of \$1,181.61. The Prudent reserve had interest of \$10.26 for an account balance is \$10,353.32. Current projected deficit for 2011 is \$13,218.73.

Alternate Treasurer – Pam C: Reported on current status of receipts and that the Expense Form is not on the new website yet.

Convention Chair James V: Summer Assembly income included \$500.00 for 50 coffee cards, \$6.00 for coffee bar 7th tradition donations, \$550.00 for 50 breakfast coupons and \$690.00 for 46 lunch coupons for total income of \$1,746.00. Summer Assembly expenses included \$74.45 for registration supplies, \$504.00 for coffee expense, \$900.00 for meeting room expense, \$720.00 for meeting room credit and \$1240.00 for food coupons, for total expenses of \$1,998.45. Income versus expenses was \$(252.45). Attendance was 170, with 110 voting members registered.

2010 Area Inventory Review Ad-Hock Committee Report – DCM District 53, Zach M: We are currently reviewing the November 2010 Area Inventory notes and are formulating our individual recommendations for any changes to the Area Policies and Procedures or other Area guidelines. We anticipate meeting before the Sept. 2011 Assembly to finalize our committee recommendations. Will be in touch with the Area Chair this month to discuss the most appropriate mechanism for bringing these recommendations to the Area (directly to Area Assembly or through Area Committee, as motions or just a report, etc.).
